

# Important Information about OTG Capital's Asset Backed Investment Trust

## ✓ Expected returns 9.11%\* pa in asset backed commercial loans

Expect to earn higher returns than bank mortgage rates, cash deposits, fixed term interest yields, cash management trusts, other term interest funds or bank bills.

## ✓ Regular monthly income

Choose between regular monthly income distributions or the reinvestment plan to suit your cash flow or wealth accumulation strategy.

## ✓ Underlying investments secured against 1<sup>st</sup> and 2<sup>nd</sup> mortgages in direct real property

All our investments are secured using direct real property as collateral with no greater than ~67% LVR on 1<sup>st</sup> mortgages and ~70% on 2<sup>nd</sup> mortgages.

## ✓ Excellent investment to enhance yield

OTG Capital's Asset Backed Investment Trust provides you with an excellent investment vehicle, while having recourse to the asset where there is a default by the borrower. The risk of commercial lending is rewarded by higher yields and returns.

## ✓ Ability to withdraw

The Trust is *illiquid*, meaning it is **not an "at call" facility**. There is no automatic right to withdraw, however investors can apply to withdraw part or all of their funds and OTG Capital will seek to return the funds within 45 – 60 days depending on the Trust liquidity at the time of the request.

## ✓ Co-Investment / First Loss Position

You can draw additional comfort from our own Fund Manager's co-investment position that places between 5–15% of our own funds in the same investments that our clients are participating in. In this way, together with our "**first loss position**", where OTG Capital's Fund Management will take losses up to 5% of the total fund, ahead of our investor clients.
